FOREWORD

Ladies and Gentlemen, Dear Colleagues,

We are pleased to submit our educational programme "European Social Dialogue" 2021/22.

EZA's education work as regards the European social dialogue is focused on conveying knowledge, exchanging experience, connecting stakeholders and passing on acquired knowledge. Our European seminars are characterised by cultural diversity, multiple languages as well as different educational needs and ranges of experience. With one common goal: to create a social Europe that serves its people.

The coronavirus pandemic has shown how quickly our daily routines can change. Not only with regard to social distancing, face masks, hygiene concepts and restricted travel opportunities, but also (and in particular) new forms of work. In our educational work, which relies on direct interpersonal contacts for the successful communication of knowledge and experience, we were also challenged to find new – digital – ways.

I would like to thank all of our project partners who worked to establish the "new normal" in our educational work, which utilises more technical options and picks up on new challenges.

Other issues include: the migration and mobility of workers, the situation of young workers in the labour market and the importance of professional training, the integration of particularly disadvantaged groups in the labour market, digitisation, the values of Christian social teachings as a guide for workers' organisations, capacity building, equal opportunities for women and men in the labour market and equal pay for equal work, as well as workplace safety and health with a focus on the new EU-OSHA campaign on musculoskeletal disorders.

The special project for labour organisations in the western Balkan region will be continued.

Multipliers from unions and other labour organisations, particularly young talent, represent the target group of our continuing education seminars.
